THE ECO-TOUR PROGRAM IS A UNIQUE FIELD TRIP WHERE STUDENTS EXPLORE TREEPEOPLE'S COLDWATER CANYON PARK GUIDED BY ECO-EDUCATORS THAT CONNECT THE CYCLES OF NATURE BACK TO A STUDENT'S OWN BACKYARD.
